Excellent 100 scholarship programme

In year 2011 Excellent 100 programme was launched to grant the opportunity to the very best high school graduates to stay in Lithuania and study free of charge in the programme of their choice. More than 262 ISM students who finished secondary schools with the best grades have studied free of charge since the beginning of the Excellent 100 scholarship programme. Companies are providing about 15 - 20 scholarships each year. The rest of the Excellent 100 scholars are supported by ISM University.

More than 1000 ISM alumni have donated to a need based scholarship fund

In 2012 ISM alumni became involved in fundraising activities to collect financial support to the scholarship fund for disadvantaged people.
