PROCEDURE FOR GRANTING TUITION FEE DISCOUNTS AND SCHOLARSHIPS

I. GENERAL PROVISIONS

- 1.1 The Procedure for Granting Tuition Fee Discounts and Scholarships (hereinafter referred to as the "**Procedure**") of ISM University of Management and Economics, UAB (hereinafter referred to as "**ISM**") establishes the Procedure for Granting Tuition Fee Discounts and/or Scholarships for Bachelor's Degree , International Master's Degree, Executive Master's Degree and Doctoral Degree Studies. Tuition fee discounts and/or scholarships shall be granted from the funds accumulated by ISM and/or the public institution ISM Fund (hereinafter referred to as the "**Fund**") and in accordance with the provisions of the Law on Science and Studies of the Republic of Lithuania.
- 1.2 A student may only be awarded one ISM tuition fee discount and/or scholarship (i.e. ISM tuition fee discounts and/or scholarships are not cumulative), except for the ISM Achievement and ISM "I Seek More" scholarships for undergraduate studies, which may be combined with the ISM study scholarship (75% ISM study scholarship and ISM "I Seek More" scholarship, up to 100% of the tuition fee is covered), the ISM family discount, State Study Scholarship.
- 1.3 Discounts not provided for in this Procedure may exceptionally be granted by a decision of the ISM Studies or ISM Admissions Committee. Discounts may only be granted at the time of admission.
- 1.4 This Procedure shall apply to students admitted to the ISM in the current year, except for the points in this Procedure concerning the receipt and loss of ISM Achievement Scholarships, which shall also apply to students admitted earlier. The ISM Achievement Scholarships are open to all students enrolled at the ISM, irrespective of the date of their enrolment at the ISM, and who meet the requirements set out in this Procedure.
- 1.5 The ISM Discounts and Scholarships Review Committee, appointed by order of the Rector, shall have the right to decide to apply full tuition fees to the student and/or to withdraw any ISM scholarship and/or discount awarded to him/her in the following cases:
 - 1.5.1 After losing the student status;
 - 1.5.2 By the decision of the ISM Committee on Ethics, due to the seriousness and severity of the violations of the Code of Ethics;
 - 1.5.3 If, at the end of the academic year, the student's average academic results are lower than the average results of the students in the same year, of the same study programme and form;
 - 1.5.4 Failure to meet financial obligations;
 - 1.5.5 The ISM Achievement Scholarship shall also be cancelled in cases where the student's average grade at the end of one academic year is lower than that of the ten highest-ranking ISM undergraduate students in the same year (the ranking shall be in accordance with the procedure laid down in point 2.1 of this Procedure), or where the student is granted an academic leave.

1.5.6. The discount for employees of the sponsoring companies shall be cancelled for the following semesters of study when the student is granted an academic leave.

1.6 If a student is awarded a Social Incentive scholarship by the Fund, ISM shall notify the Fund if the ISM Discounts and Scholarships Review Committee, appointed by the Rector's order, establishes that one of the cases set out in point 1.5 of this Procedure applies. The Fund shall decide on the further payment/cancellation of the scholarship awarded by the Fund in accordance with its internal procedures.

1.7 The 100 Talent Scholarship is cancelled in the following cases:

1.7.1 If the Student to whom the scholarship has been awarded has interrupted/suspended his/her studies, has been removed from the student lists;

1.7.2 If the average of the academic year grades of the Student who has been awarded the scholarship is below the course average.

1.8 From the moment of the loss of the scholarship, the full Tuition fee shall be payable by the student.

1.9 Bachelor's and International Master's students who lose their scholarship shall pay the tuition fees as of the date of the loss of the scholarship, at the ISM tuition fee valid at the date of signing the study agreement.

1.10 ISM discounts and/or scholarships do not apply to the cost of additional courses and/or services.

1.11 All ISM scholarships/discounts are intended solely for the payment of tuition fees and are not paid directly to the student.

1.12 The student who has received an ISM scholarship and/or discount, undertakes to contribute to the promotion and dissemination of ISM.

II. TUITION FEE DISCOUNTS AND SCHOLARSHIPS FOR BACHELOR STUDENTS (CITIZENS OF THE REPUBLIC OF LITHUANIA)

2.1 ISM offers the following tuition fee discounts and scholarships:

2.2 Scholarship awarded by the ISM Fund:

2.2.1 ISM Social-Incentive Scholarship. The Scholarship is open to active, socially minded young people facing financial difficulties. The Scholarship is awarded for the entire period of study and covers part or all of the tuition fee. The awarding and losing of the ISM Social-Incentive Scholarship is governed by the Fund's Regulations for the Awarding of Incentive Scholarships. 2.3 State Study Scholarship

2.3.1 Bachelor's degree students who have been admitted to ISM with the highest competitive scores may be awarded a State Study Scholarship by the decision of the ISM Admissions Committee in cases established by the legislation of the Republic of Lithuania.

III. TUITION FEE DISCOUNTS AND SCHOLARSHIPS FOR BACHELOR'S DEGREE STUDENTS (NON-CITIZENS OF THE REPUBLIC OF LITHUANIA)

3.1 First-time applicants who pass the ISM Academic Knowledge Test with the highest scores may be eligible for tuition fee discounts of up to 100% of the student's tuition fees.

3.2 Applicants may be eligible for the **ISM 15% Family Scholarship**, the terms for which are defined in paragraph 2.1 of this Procedure.

3.3 The best candidates with Ukrainian citizenship may be awarded an **ISM Study Scholarship of 25%** by the decision of the ISM Admissions Committee, the terms for which are defined in paragraph 2.1 of this Procedure.

3.4 Students found by agents with whom ISM has signed cooperation agreements may receive a 10% tuition fee discount, which is granted for the entire study period.

3.5 The ISM Achievement Scholarship is open to all students, regardless of their nationality. The terms for receiving the scholarship are defined in paragraph 2.1 of this Procedure.

IV. TUITION FEE DISCOUNTS AND SCHOLARSHIPS FOR INTERNATIONAL MASTER'S DEGREE STUDENTS

4.1 **ISM Graduate Discount.** ISM Bachelor's graduates applying to the ISM International Master's programme are eligible for the **ISM Graduate Discount**. In addition, a discount is available for ISM International Master's graduates enrolled in a second ISM International Master's programme. The ISM Graduate Discount covers 30% of the programme price in force at the time of signing the study agreement.

4.2 **ISM Study Scholarship.** International Master's degree students admitted to ISM with the highest competitive scores and/or merited for outstanding study and research results, significant achievements in national and international competitions during the bachelor's study period and afterwards, social activity, or having outstanding professional achievements, may be granted a **ISM Study Scholarship** covering up to 50% of the tuition fee by decision of the ISM Admissions Commission. The exact amount of the discount is published each year on the ISM website.

4.3 **Discount for employees of sponsoring companies.** A 15% discount is granted, calculated on the tuition fee applicable on the date of signing the study agreement. The discount is granted at the time of admission to the study programme, when signing the study agreement. The discount

applies if the company donates to the Fund in the form of money, services or items with a total value of EUR 20 000 or more per year.

4.4 ISM Partner Discount. A discount on tuition fees is available for companies that delegate staff and pay part or all of the tuition fees for the International Master's and Executive Master's programmes. The amount of the discount depends on the number of delegated students and is calculated on the tuition fee for the current semester in force on the date of the conclusion of the study agreement. For subsequent semesters, the amount of the discount is recalculated before the start of the following semester, depending on the number of staff delegated by the company in that semester for the International Master's and Executive Master's programmes. The following discounts are available: for delegating 3-4 employees - 10%, 5-6 employees - 15%, 7-9 employees - 20%, 10 or more employees - 25%.

4.5 Discounts valid only for the citizens of the Republic of Lithuania:

4.5.1 International Master's degree students who have been admitted to ISM with the highest competitive scores may be awarded a **State Study Scholarship** by the decision of the ISM Admissions Committee in cases provided for by the legislation of the Republic of Lithuania.

4.5.2 **Accelerate Programme.** International Master's students selected by the ISM Admissions Committee on a competitive basis may apply for the Accelerate programme, whereby tuition fees are deferred until the student's income reaches the income limit stipulated in the Accelerate contract. The deferred tuition fees start to be paid according to the payment schedule set out in the Accelerate contract annex. In addition to academic performance, applicants' motivation during the interview is also considered in the selection process.

Discounts applicable to foreign nationals:

4.7 Students from foreign countries who receive support from the Education Exchange Support Fund, on the decision of the ISM Admissions Committee, may additionally receive a 10% discount on the tuition fee for the entire study period.

4.8 Students found by agents with whom ISM has signed cooperation agreements may be eligible for a 10 % tuition fee discount for the entire study period.

4.9 Foreign nationals who have spent a semester at ISM during their undergraduate studies under the exchange and double diploma programmes may, at the time of admission, by the decision of the ISM Admissions Committee, be granted a discount of up to 25% off the price of the International Master's degree in effect at the time of admission.

4.10 The best candidates holding Ukrainian citizenship may, upon the decision of the ISM Admissions Committee, be granted a 25% discount on the tuition fee in effect at the time of admission.

V. TUITION FEE DISCOUNTS FOR ISM EXECUTIVE MASTER'S DEGREE STUDENTS

5.1 For companies delegating 3-4 employees per semester, a 10% tuition fee discount shall be applied to employees; for 5-6 employees, a 15% tuition fee discount shall be applied; for 7 or more employees, a 20% tuition fee discount shall be applied; and for 10 or more employees, a 25% discount shall be applied to the one (current) semester of study for which the numbers of employees referred to in this paragraph are delegated. For the purpose of assessing the amount of the discount, all the employees delegated by the company are counted during the current semester of study for the Executive Master's and International Master's programmes. The discount

shall in all cases be calculated on the basis of the rate applicable on the date of signature of the study agreement specified in the price list on the date of the agreement.

5.2 Graduates of the ISM Executive Master's and Master of Business Administration (MBA) programmes who continue their studies in individual modules receive a 30% tuition fee discount. Graduates of the ISM Bachelor's and International Master's programmes who continue their studies in the ISM Executive Master's programme are entitled to 20% discount.

5.3 For Executive Master's students who continue their studies after completing 3 modules, a 10% discount is applied to the study of the 4th and other selected modules, calculated on the module price specified in the study agreement in force at the time. The discount does not apply to the Final Thesis module.

5.4 Employees of ISM partners and sponsoring companies whose sponsorship to ISM is at least EUR 20 000 per year, are entitled to a 15% tuition discount for the duration of the sponsorship agreement. The discount in all cases is calculated on the basis of the tuition fee in force on the date of signing the tuition fee agreement as quoted in the price list on the date of the agreement.

5.5 New entrants who join a colleague or another acquaintance/friend, as well as new entrants who provide the name of a friend or colleague, shall be entitled to a 10 % discount for the first semester of studies for both new entrants.

5.6 Participants of the STEP UP 2 project (who meet the STEP UP 2 competition regulations) will receive a 50% discount on the first study module. The number of places funded by STEP UP 2 and their funding terms are determined by the Admissions Committee each academic year.

VI. TUITION FEE DISCOUNTS FOR ISM EXECUTIVE MBA (MASTER'S IN BUSINESS ADMINISTRATION) STUDENTS

6.1 For companies delegating 3 or more employees a 15% discount shall be applied, calculated on the tuition fee applicable on the date of conclusion of the study agreement, for the entire period of study.

6.2 Graduates of the ISM Bachelor's and International Master's, who continue their studies in the ISM Executive MBA (Executive Master's in Business Administration), shall be entitled to a 15 % discount and graduates of Executive Master's (who have completed the full Executive Master's programme) shall be entitled to a 30 % discount calculated on the tuition fee applicable on the date of conclusion of the study agreement for the entire period of study.

6.3 The spouse of a student or a graduate of the ISM Executive MBA (Executives Master's in Business Administration) programme shall be entitled to a 10% discount on the full programme of study, calculated on the basis of the tuition fee applicable on the date of conclusion of the study agreement, as indicated in the price list, for the entire period of study.

6.4 Representatives of non-profit and governmental organisations may be awarded a scholarship of up to 50% of the total cost of the ISM Executives MBA (Master's in Business Administration) degree programme. Candidates applying for the scholarship are required to complete the scholarship application form on the ISM website. The scholarship application is considered only after the candidate has been admitted to the study programme.

6.5 Applicants to the ISM Executive MBA in Business Administration programme may be eligible for 10% early bird discount. The discount is applied to the total tuition fee applicable at the time of

admission and its terms and conditions are published on the website <https://www.ism.lt/executive-school/executive-mba/>

6.6 Candidates applying to the ISM Executive MBA (Master's in Business Administration) programme with a recommendation from a graduate of this programme are granted a 15% discount on the total tuition fee. This discount is only available to applicants applying before the end of the general admission period. The exact dates of admission are published on www.ism.lt/priemimas.

VII. TUITION FEE DISCOUNTS FOR DOCTORAL STUDENTS

7.1 Doctoral students who are graduates of the ISM Bachelor's Degree, International Master's Degree, Executive Master's Degree, or ISM Executive MBA Degree are entitled to the ISM Graduate Student Discount for their loyalty to the ISM Community. The ISM Graduate tuition fee discount is 30% of the tuition fee in force on the date of conclusion of the study agreement, for the entire period of study.

7.2 Students enrolling in ISM doctoral studies from higher education institutions with which ISM has signed institutional cooperation agreements, studying in doctoral study programmes as a student or a free mover, may be entitled to special discounts approved by a separate order of the Rector.

7.3 Doctoral students who obtain a high competitive score at the time of admission shall be granted a tuition fee discount of up to 40% of the total study period (in case of the use of this discount point 7.4 of this Procedure does not apply):

7.3.1 Candidates with a competitive score of 8.0 - 9.0 at the time of admission to the doctoral programme shall be granted a 30% discount;

7.3.2 Candidates who obtain a competitive score between 9.01 and 10 at the time of admission to the doctoral programme shall receive a 40 % discount.

7.4 Candidates who have not been admitted to the ISM doctoral programme during the general admission process or who have not received a Study Scholarship from the State shall be granted a 30 % discount for one doctoral subject.
