## Guidelines for Participants with Fewer opportunities at ISM University of Management and Economics

## 1. Erasmus+ inclusion support

- 1.1. Priorities of the Erasmus+ programme<sup>1</sup> seek to promote equal opportunities and access, inclusion, diversity, and fairness across all its actions. Organizations and the participants with fewer opportunities themselves are at the heart of these objectives and with these in mind, the programme puts mechanisms and resources at their disposal.
- 1.2. To increase the qualitative impact of inclusive approach actions and ensure equal opportunities to people with fewer opportunities in Erasmus+ programme ISM university implements guidelines for additional funding for students and/or staff members that are going on Erasmus+ exchange abroad. There are two types of funding mechanisms for inclusion support of Erasmus+ participants:
  - 1.2.1.**An individual top-up support** for mobile Erasmus+ students from groups of participants with fewer opportunities (see article 2.);
  - 1.2.2.**An individual support for mobile Erasmus+ participants based on real costs** when a participant faces personal, physical, mental or health-related conditions that make participation in the mobility action (for studies or traineeships) not possible without extra financial or other support (see article 3.).

## 2. Individual top-up support

- 2.1. Students meeting the following eligibility criteria are eligible to apply for individual top-up support:
  - 2.1.1.All ISM undergraduate, graduate and doctoral students who are leaving for international exchange programme (for studies or traineeships) with Erasmus+ grant (scholarship);
  - 2.1.2. All ISM undergraduate, graduate and doctoral students who belong to at least one of the below-mentioned group of participants with fewer opportunities (see article 2.3).
- 2.2. Students who meet the above-mentioned eligibility criteria are eligible to receive a top-up amount (additional to the individual support of their Erasmus+ grant (scholarship)) of **250 EUR/month** in case of long-term mobility for studies or traineeships; or 100 EUR for a physical mobility activity period of 5-14 days and 150 EUR for the one of 15-30 days in case of short-term mobility for studies or traineeships.
- 2.3. Groups of participants with fewer opportunities at ISM university:
  - 2.3.1.Students who are described by the State Studies Foundation (<a href="https://vsf.lrv.lt/lt/studentams/soc-stipendijos">https://vsf.lrv.lt/lt/studentams/soc-stipendijos</a>) as eligible receivers of a social scholarship;
  - 2.3.2. Students receiving the ISM social-incentive scholarship;
  - 2.3.3.Students with a refugee background;
  - 2.3.4. Students with children (under the age of 12 years).
- 2.4. Students belonging to one (or more) of the above-mentioned groups (see article 2.3), should present relevant documents, i.e., certification or other proof that student is receiving a social scholarship; certification or other proof indicating that student has a refugee status; certification

- or other proof that student has children under the age of 12 years (at the time of submitting the exchange application), etc.
- 2.5. After the mobility selection results are announced, students who are selected for mobility and are receiving Erasmus+ grant (scholarship) have to inform ISM International Studies Office (ISO) via email that they are participants with fewer opportunities, and to attach relevant documents confirming that they belong to one (or more) of the groups defined by ISM as participants with fewer opportunities (see article 2.3.)

## 3. An individual support based on real costs

- 3.1. An additional grant can be awarded to participants with a physical, mental or other disability based on the real costs. It is intended to cover additional costs where the individual top-up support would not be able to cover these costs. It is specifically intended to cover the extraordinary financial support required for participants with physical, health, mental disabilities to enable them to participate in a mobility as well as for preparatory visits and accompanying persons.
- 3.2. Participants meeting the following eligibility criteria are eligible to apply for individual support based on real costs:
  - 3.2.1. All ISM undergraduate, graduate, doctoral students, administrative staff and academic staff who are leaving for international exchange programme (for studies/traineeship/teaching/training)) with Erasmus+ grant (scholarship);
  - 3.2.2. All ISM undergraduate, graduate, doctoral students, administrative staff and academic staff with any physical, health or mental disabilities or any other related condition.
- 3.3. Expenses that can be funded:
  - 3.3.1. Additional costs for facilities and /or services, depending on the nature of the illness/disability and/ or condition.
  - 3.3.2. Subsistence and travel expenses of the person accompanying the participant, if justified.
  - 3.3.3.Preparatory visit costs. The costs can be allocated to: the subsistence and / or travel expenses of the participant, the subsistence and / or travel expenses of the person accompanying the participant, etc., if justified.
- 3.4. Participants meeting the criteria shall provide additional documents before the start of the mobility. Such documents have to validate requirements for additional costs depending on the nature of the illness and/or disability. The need for these expenses must be based on medical documents, i.e. confirmed in an extract from medical documents issued by medical institution. Participant has to include the prices of the facilities and/or services in the country of the mobility.
- 3.5. Documents justifying the participant's diagnosis or relevant condition must be sent to International Studies Office as soon as possible after accepting selection results but no later than 6 weeks before the participant's study/traineeship/teaching or training visit.
- 3.6.On behalf of the participant, ISM International Studies Office shall submit the application requesting the additional grant to the Education Exchanges Support Foundation and informs participants of the results.
- 3.7. Up to 80 per cent of the confirmed individual support amount based on real costs shall be paid prior leaving for mobility abroad or as soon as the confirmation from Education Exchanges Support Foundation is received. The remaining amount shall be paid after participant's return and upon the submission of requested documents.
- 3.8. After the mobility period ends, participant must submit all related documents about his/her expenses related to the granted individual support based on real costs (copies of invoices, rental housing contracts, payment orders, etc.) to the International Studies Office via email.
